GENERAL JOB DUTIES

- Screening of referrals with standardized assessment to determine eligibility.
- Delivery of Early Intervention services to young children with special needs and their families, including consultation and coordination with staff of community service providers and therapy staff.
- Attendance and participation in conferences, in-services, seminars and training.
- Participation in developing and implementing the IFSP.

ESSENTIAL JOB DUTIES

- Complete screenings, assessments and evaluations from referrals and annual reviews.
- Participate in and complete the IFSP initially and annually and at 6 month reviews.

- Develop recommendations, goals, and treatment plan for children enrolled in the program.
- Provide special instruction, family training and support to children/families/caretakers.
- · Consult and communicate with other professionals working with the child on the IFSP.
- Document in writing all contacts, billings and progress.
- Maintain credentials necessary for CBO billing.

ADDITIONAL JOB DUTIES

- Participate in and present trainings to staff, families and community members.
- Communicate information about Early Intervention to the community.
- Complete other duties as assigned.

QUALIFICATIONS

- Must have a bachelors degree or higher in Early Childhood Education, Early Childhood Special Education, Special Education; Deaf/Hard of Hearing, Child Development/Family Studies, Elementary Education, Developmental Psychology, or Social Work.
- Must Have or be able to obtain Early Intervention credentials for Developmental Therapy.
- Valid Illinois driver's license with a driving record acceptable to the agency insurer and own transportation is required.

PHYSICAL DEMANDS

Must be able to exert up to 20 pounds of force occasionally, and/or up to 10 pounds of force frequently, and/or a negligible amount of force constantly to move objects.
